



# How changing attitudes toward data sharing could accelerate smart city adoption


## Question 1: What do you think will be the key sources of funding for smart city technology in your city?




## Question 2: What do you see as the top-three forms of mobility in your city in the next five years?




## Question 3: What do you think will help drive the development of smart cities around the world?




## Question 4: What do you think will have the greatest impact on the development of smart city technologies globally?



## Question 5: Which of the UN Sustainable Development Goals will drive smart city development?




## Question 6: In which sectors do you expect to see the most smart city activity?




**Question 7: Which technologies will take off in smart cities?**




**Question 8: What do you think are the biggest obstacles to smart city rollout?**




**Question 9: How comfortable are you personally with sharing/allowing access to your personal data for the purposes of developing/improving smart city technology?**




**Question 10: Would you be willing to trade reduced privacy for better services?**



**Question 11: Do you think laws governing privacy and personal data need to be relaxed if smart city rollouts are to progress?**




**Question 12: What do you think will drive energy generation transition in smart cities?**




